ASSESSING THE CAPABILITIES AND CHALLENGES OF BARANGAY TANODS AS FIRST RESPONDERS: A STUDY IN SELECTED BARANGAYS IN CABANATUAN CITY

ABSTRACT

This study was conducted in selected barangays of Cabanatuan City and focused on the roles and responsibilities of Barangay Tanods as first responders in various emergency situations, including crimes, natural disasters, and medical incidents. It also examined the challenges they face in carrying out their duties. Using a quantitative research approach, data were gathered from Barangay Tanods to assess their performance and the community's level of trust and satisfaction in their services.

Findings revealed a strong level of community confidence in the tanods' ability to apprehend suspects during criminal activities and effectively manage traffic during emergencies and public events. However, the study also identified significant challenges, with inadequate resources and equipment, as well as limited legal knowledge, as the most vital problems that hinder their effectiveness and safety.

Based on these findings, the study recommends targeted interventions such as specialized training, legal education, and the provision of essential equipment to enhance the capabilities and performance of Barangay Tanods as frontline responders in their respective communities.

INTRODUCTION

Barangay Tanods play a critical role in maintaining peace and order within their respective communities. They are the front liners who are responsible for keeping the barangay's peace and good relations and responding to emergencies and disasters (Cruz R. et al., 2021). The establishment of the barangay Peacekeeping Action Team (BPAT) serves a pivotal entity responsible for implementing a community-focused policing and public safety system. Barangay Tanods are civilian volunteers tasked with protecting communities from lawless elements and demonstrating a significant dedication to deterring crime, particularly in areas with limited police presence (Austria-Cruz, 2020). Usually, they are the first to respond during emergencies, whether they are criminal incidents, natural disasters or health crises. Further, the barangay tanods' duties and responsibilities include: supporting barangay officials in crime prevention and promoting public safety through patrolling, reporting to the offices concerned of any disruptions or unfair events, tracking the presence and actions of criminals and illegal elements, assisting the Philippine National Police and "lupong tagapayapa" (De Asis, J., et al., 2020). However, despite their vital role, little is known about their actual capabilities and the challenges they face in executing their This research aims to assess the capabilities and difficulties encountered by the barangay tanods as first responders in selected barangay in Cabanatuan City. By identifying their challenges and assessing their capabilities, the findings of the

study will serve as a baseline in designing an Extension Program that will offer evidence-based recommendations for local government units in enhancing the ability of the barangay tanods.


OBJECTIVES OF THE STUDY

The general objective of this study is to assess the capabilities and challenges faced by the barangay tanods as first responders. Specifically, the study aims to:

- 1. Examine the roles and responsibilities of barangay tanods as first responders;
- 2. Identify the challenges faced by the barangay tanods in performing their roles; and
- 3. Provide recommendations for improving the efficiency of barangay tanods as first responders

METHODOLOGY

The study focused on selected barangays in Cabanatuan City. The respondents were the barangay tanods. The research focused on their roles and responsibilities as first responders in dealing with crimes, natural disasters and medical emergencies. Likewise, the study tackled the challenges faced by the barangay tanods in performing their duties as first responders. This study also used a quantitative data collection technique.

As can be seen from the table, Barangay Tanods can apprehend individuals caught committing crimes in their presence and hand them over to the police for proper legal procedures (3.52) obtained one of the highest scores, showing strong community trust in tanods' capacity to act decisively in crime prevention and immediate response. Intertwined with indicator number 2 is the BarangayTanods help manage and direct traffic to ensure the safety of pedestrians and motorists in cases of road accidents, heavy traffic or community events (3.52) this score reflects strong community satisfaction with how tanods ensure safety during traffic-related incidents or events.

The findings agrees to the study of Monte et al. (2023) stating that the efficacy of BPAT in keeping peace and order, demonstrating exceptional proficiency in various areas such as safety for society, law enforcement, environmental preservation, dispute settlement, and catastrophe readiness. This implies that barangay tanods are


generally perceived as fulfilling their duties effectively in their multifaceted roles as first responders in the community.

Likewise, the indicator that obtained the lowest are; BarangayTanods prepare incident reports that document what transpired, which can be used as evidence in further investigations or legal actions after responding to incidents (2.86), this implies that tanods need capacity-building in administrative duties and crisis response coordination and Barangay Tanods inform residents of important barangay directives, advisories and announcements related to health, safety and security (2.90) also indicate a need for more specialized training or equipment support.

The findings agrees to the study of Aydinan (2021), stating that in understanding barangay tanods duties and obligations as initial responders, emphasizing the importance of training programs to enhance their competencies is very essential.

As can be inferred from the table, inadequate resources and equipment (3.7) ranked first among the challenges faced by the Barangay Tanods, this directly affect the ability of tanods to perform effectively and safely. Next in rank is the Limited Legal Knowledge (3.6), this implies limitations in their day to day operations.

The findings agrees to the study of Sumad-on (2020) stating that the difficulties barangay tanods have in preventing crime, including inadequate resources like vehicles for patrol, training in self-defense techniques, and essential equipment for effective crime prevention.

CONCLUSIONS

Based on the findings, the following conclusions were drawn:

- 1. It can be conclude a strong level of community trust and satisfaction in the performance of Barangay Tanods, particularly in two critical areas of their duties: apprehending individuals caught in the act of committing crimes and managing traffic during emergencies and community events. Both indicators underscore the public's confidence in the tanods' ability to respond swiftly and effectively to maintain peace and order.
- 2. It can be clearly conclude that inadequate resources and equipment and limited legal knowledge are the most vital challenges faced by Barangay Tanods. These issues significantly hinder their ability to perform their duties effectively and safely. Without the proper tools and a clear understanding of legal procedures, their capacity to respond to emergencies, enforce laws, and protect the community is compromised

RECOMMENDATIONS

Based on the conclusions, the following are recommended:

- 1. Conduct specialized training in traffic control, accident scene management, and basic first aid to elevate their preparedness in high-pressure situations.
- Organize regular seminars and workshops in collaboration with the PNP, local prosecutors, or law schools to educate tanods on laws related to arrest, search and seizure, rights of the accused, barangay ordinances, and citizen's arrest procedures.
- 3. Develop simplified legal handbooks or quick reference guides tailored for Barangay Tanods, written in Filipino or local dialects for better comprehension.
- 4. Encourage participation in accredited training programs like those offered by the DILG, TESDA, local colleges or Universities focusing on community safety and legal processes.
